






## GOVERNOR SCHEME OF DELEGATION

The Full Governing Board (FGB) meets once every half term, with each governor also serving on one of the main two sub committees, also meeting once every half term. Our two main sub committees are;

**Core Business Team Committee** - which includes finance, personnel, health & safety, premises and communication including GDPR.

**Teaching and Learning Committee** - which includes curriculum and assessment, safeguarding, behaviour, attendance, equality, admissions, pupil premium and CIC.







We also have a **Pay and Performance Committee** that meet once a term and a **First Committee** and **Appeals Committee** that are convened as and when required. **HTPM** is the Head Teacher Performance Management committee who meet with the Executive Head twice a year to monitor their targets.
